

### **PREFACE**

#### GENERAL COMMENTS

Congratulations on the purchase of your new KODIAK product! This product was carefully designed and manufactured to give you many years of dependable service. Only minor maintenance (such as cleaning and lubricating) is required to keep it in top working condition. Be sure to observe all maintenance procedures and safety precautions in this manual and on any safety decals located on the product and on any equipment on which the attachment is mounted.

This manual has been designed to help you do a better, safer job. Read this manual carefully and become familiar with its contents.

WARNING! Never let anyone operate this unit without reading the "Safety Precautions" and "Operating Instructions" sections of this manual.

> Always choose hard, level ground to park the vehicle on and set the brake so the unit cannot roll.

Unless noted otherwise, right and left sides are determined from the operator's control position when facing forward.

NOTE: The illustrations and data used in this manual were current (according to the information available to us) at the time of printing, however, we reserve the right to redesign and change the attachment as may be necessary without notification.

#### **BEFORE OPERATION**

The primary responsibility for safety with this equipment falls to the operator. Make sure the equipment is operated only by trained individuals that have read and understand this manual. If there is any portion of this manual or function you do not understand, contact your local authorized dealer or the manufacturer to obtain further assistance. Keep this manual available for reference. Provide the manual to any new owners and/or operators.

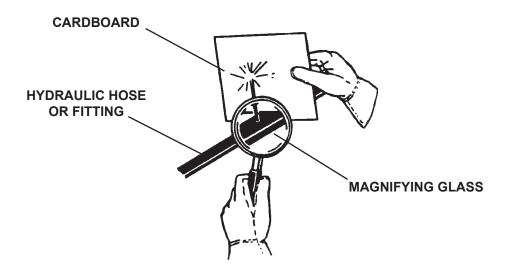

- Do not mount this attachment onto any prime mover that exceeds the recommended HP, operating weight OR lifting capacity for your grapple.
- Do not exceed the lifting capacity of your prime mover.
- Operate only from the operator's station.
- When operating on slopes, drive up and down, not across. Avoid steep hillside operation, which could cause the prime mover to overturn.
- Reduce speed when driving over rough terrain, on a slope, or turning, to avoid overturning the vehicle.
- An operator must not use drugs or alcohol, which can change his or her alertness or coordination. An operator taking prescription or over-the-counter drugs should seek medical advice on whether or not he or she can safely operate equipment.
- Before exiting the prime mover, lower the attachment to the ground, apply the brakes, turn off the engine and remove the key.
- Never heap load heavy material where the combined weight of the bucket and material could exceed the rated lifting capacity of the loader.
- Be sure the load does not stick out too far in front of the bucket. A light load sticking out too far can have the same tipping effect as a heavy load carried in close.
- When using the grapple, lift the load slightly and make sure that the load is secure. If the load appears to be unstable, lower the load, open the grapple and reposition the load to attain full stability.

#### **EQUIPMENT SAFETY PRECAUTIONS**



#### TRANSPORTING THE ATTACHMENT

- Travel only with the attachment in a safe transport position to prevent uncontrolled movement. Drive slowly over rough ground and on slopes.
- Use extra care when loading or unloading the attachment onto a truck or trailer.
- When driving on public roads use safety lights, reflectors, Slow Moving Vehicle signs etc., to prevent accidents. Check local government regulations that may affect you.
- · Do not drive close to ditches, excavations, etc., cave in could result.

#### MAINTAINING THE ATTACHMENT


- Before performing maintenance, lower the attachment to the ground, apply the brakes, turn off the engine and remove the key.
- Never perform any work on the attachment unless you are authorized and qualified to do so. Always read the operator service manual's before any repair is made. After completing maintenance or repair, check for correct functioning of the attachment. If not functioning properly, always tag "DO NOT OPERATE" until all problems are corrected.
- Worn, damaged, or illegible safety decals must be replaced. New safety decals can be ordered from Paladin.
- Never make hydraulic repairs while the system is under pressure. Serious personal injury or death could result.
- Never work under a raised attachment.

# DECALS

#### **DECAL PLACEMENT**

#### **GENERAL INFORMATION**

The diagram on this page shows the location of all the decals used on your attachment. The decals are identified by their part numbers, with reductions of the actual decals located on the following page. Use this information to order replacements for lost or damaged decals. Be sure to read all decals before operating the attachment. They contain information you need to know for both safety and attachment longevity.



**IMPORTANT:** Keep all safety decals clean and legible. Replace all missing, illegible, or damaged safety decals. When replacing parts with safety decals attached, the safety decals must also be replaced. Safety decals are available, free of charge, from your local dealer or Paladin.

**REPLACING SAFETY DECALS**: Clean the area of application with nonflammable solvent, then wash the same area with soap and water. Allow the surface to fully dry. Remove the backing from the safety decal, exposing the adhesive surface. Apply the safety decal to the position shown in the diagram above and smooth out any bubbles.

### INSTALLATION

#### **GENERAL INFORMATION**

These KODIAK grapples were designed to be used on compact/utility tractors with a maximum of 1800 pounds lifting capacity on the single grapple and 2400 pounds lifting capacity on the dual grapple. Operating this attachment on a prime mover that exceeds any of the prime mover specifications will cause damage to the attachment and void all warranties.

Due to the various different compact/utility tractors and loaders that these attachments can be mounted on, the dual grapple buckets are shipped without the hydraulic hoses and couplers. These can be purchased from your local dealer.

#### **HOSE REQUIREMENTS**

Power and return hoses and couplers must be purchased from your dealer to install the Heavy Duty Dual Grapple onto your loader. The hoses must be long enough to accommodate for complete roll out of the bucket, rated for the maximum hydraulic pressure of your loaders hydraulic system and a minimum of .38" in diameter.

The hoses must also be equipped with a 6MP end to connect to the grapple bucket and the couplers must mate up to the auxiliary hydraulic couplers on your loader.

#### INSTALLATION

Install the bucket by following your tractor and loader operator's manual for installing an attachment.



WARNING! To Avoid Serious Personal Injury, make sure the bucket is securely latched to the attachment mechanism of your unit. Failure to do so could result in separation of the bucket from the unit.

Install the power and return hoses (purchased from your dealer) to the fittings on the grapple bucket followed by the quick couplers. Connect the hydraulic quick couplers to the auxiliary hydraulics and route the hoses in such a fashion as to prevent chafing and pinching and secure in place wherever necessary.

Start engine and slowly cycle the bucket cylinder(s) several times to purge system of air, check for proper hydraulic connection, hose routing, and hose length. NOTE: Power and return hoses must be long enough to accommodate complete rollout of the bucket.

Check the attachment for proper assembly, installation, and hydraulic leaks.

#### INSTALLATION OF BOLT-ON GRAPPLE ASSEMBLY


The bolt-on grapple assembly can be installed onto most compact/utility tractors buckets between 49" - 84" wide.

- 1. Following your prime movers operator's manual, position the loader in a suitable work place with the bucket lowered to the ground.
- Position the bolt-on grapple onto the top edge of the bucket with the longer angled edge 2. to the back of the bucket. See Figure #1 NOTE: It is recommended to use a hoist when positioning the grapple assembly.

### INSTALLATION

3. Clamp the grapple assembly firmly in place. Using the bolt-on slide mounts as a template, mark and drill eight 11/16" holes into the sides of the bucket. See Figure #1

- 4. Secure in place using the .62" UNC X 2.25" capscrews, washers and hex nuts provided. Torque to specifications. (See Bolt Torque Specifications)
- 5. Tighten the adjustment capscrews on the back of the center mount.

NOTICE: The hoses going to the grapple need to be long enough to accommodate for complete bucket roll out. If required, contact your local dealer for longer hoses and couplers to match up to your loader application.

- 6. Connect the hydraulic hoses to the loader.
- 7. Open and close the grapple to purge any air from the hydraulic system.

#### **DETACHING**

On firm level ground, close the grapple and lower the loader arms until the attachment is on the ground.

Turn off the engine. Move the control levers back and forth to relieve pressure in the line. Disconnect couplers.

NOTE: Connect couplers together or install caps to prevent contaminants from entering the hydraulic system.

Follow your tractor and loader operator's manual for detaching (removing) an attachment.

#### **OPERATION**

NOTE: Frequent lubrication of grease fittings at the end of the cylinder(s) and pivot points with a multi-purpose grease will greatly increase life of the product.

#### **OPERATION**

All grapple buckets are designed to pick up bulky, unusually shaped, or long materials that would not stay in an ordinary bucket.

- Approach the load in such a fashion that the weight will be centered on the floor of the bucket. The heaviest side should be closest to the back of the bucket and not near the bucket edge.
- 2. Before lifting, make certain the bucket is completely under the load and the bucket floor is level.
- 3. Close the grapples to their fullest extent possible and lift the bucket slightly to be certain that the load is secure.

NOTE: If the load appears to be unstable, lower the bucket to the ground, open the grapples and reposition the load to attain full stability. Repeat until full stability is achieved.

When using the grapples as a rake to drag materials into position for pick up, THE GRAPPLES MUST BE COMPLETELY OPEN.

NOTICE:

Applying a raking-type force to partially open grapples will greatly magnify the fluid pressure in the hydraulic hoses, fittings, and cylinder(s) which may cause component failure.

#### **STORAGE**

The following storage procedure will help you to keep your attachment in top condition. It will also help you get off to a good start the next time your grapple bucket is needed. We therefore strongly recommend that you take the extra time to follow these procedures whenever your unit will not be used for an extended period of time.

- Clean the unit thoroughly, removing all mud, dirt, and grease.
- Inspect for visible signs of wear, breakage, or damage. Order any parts required, and make
  the necessary repairs to avoid delays when starting next season. NOTE: Purchase only
  approved replacement parts.
- Tighten all loose capscrews and nuts.
- Replace decals if damaged, or in unreadable condition.
- Seal hydraulic system from contaminants and secure all hydraulic hoses off the ground to help prevent damage,
- Store the unit in a dry and protected place. Leaving the unit outside will materially shorten its life.

#### **Additional Precautions for Long Term Storage:**

• Touch up all unpainted and exposed areas with paint, to prevent rust.

#### **OPERATION**

#### REMOVING FROM STORAGE

- Remove all protective coverings.
- Check all nuts and bolts for proper tightness.

#### LIFT POINTS

Lifting points are identified by lifting decals where required. Lifting at other points is unsafe and can damage attachment. Do not attach lifting accessories around cylinders or in any way that may damage hoses or hydraulic components.

- Attach lifting accessories to unit at recommended lifting points.
- Bring lifting accessories together to a central lifting point.
- Lift gradually, maintaining the equilibrium of the unit.



WARNING! Use lifting accessories (chains, slings, ropes, shackles and etc.) that are capable of supporting the size and weight of your attachment. Secure all lifting accessories in such a way to prevent unintended disengagement. Failure to do so could result in the attachment falling and causing serious personal injury or death.

#### **TIE DOWN POINTS**

Tie down points are identified by tie down decals where required. Securing to trailer at other points is unsafe and can damage attachment. Do not attach tie down accessories around cylinders or in any way that may damage hoses or hydraulic components.

- Attach tie down accessories to unit as recommended.
- Check unit stability before transporting.



WARNING! Verify that all tie down accessories (chains, slings, ropes, shackles and etc.) are capable of maintaining attachment stability during transporting and are attached in such a way to prevent unintended disengagement or shifting of the unit. Failure to do so could result in serious personal injury or death.

#### **TRANSPORTING**

Follow all local government regulations that may apply along with recommended tie down points and any equipment safety precautions at the front of this manual when transporting your attachment.

#### MAINTENANCE & SERVICE

#### GENERAL INFORMATION

Regular maintenance is the key to long equipment life and safe operation. Maintenance requirements have been reduced to the absolute minimum. However, it is very important that these maintenance functions be performed as described below.


